TERMS OF EXTENSION OF CREDIT

- 1. That all purchases from Gulf Coast Mats & Equipment, LLC, are made subject to the terms and conditions set forth in this Commercial Credit Application Package;
- 2. That credit accounts established hereunder are "net 30," which require full payment of purchases within 30 days following the purchase date;
